ORDINANCE NO. 6, OF FEBRUARY 9, 2024

THE MINISTER OF STATE HEAD OF THE INSTITUTIONAL SECURITY OFFICE OF THE PRESIDENCY OF THE REPUBLIC, in the use of the attribution conferred on him by art. 87, items II and IV, of the Constitution, and in view of the provisions of art. 7, § 6, and in art. 14 of Decree No. 11,856, of December 26, 2023, resolves:
